Minutes
Latah County Republican Central Committee Meeting

Wednesday, May 25, 2016
Schierman's Event Center, 3225 Robinson Park Road, Moscow, ID

Call to order:

Note: This meeting was moved from Tuesday May 24, to Wednesday May 25, to avoid any possible violation of the state requirement to hold delegate selection meetings between 7 and 10 days after the primary. The meeting was called to order by Chairman Thomas Lawford at 6:35pm. Barry Tenney led the Pledge of Allegiance and John Wanvig Senior led the prayer.

Introductions:

Introductions were made with 34 people present from Latah and Benewah counties, including a combined 22 Precinct Committeemen.

John Freeland moved to dispense of the normal business to leave room for the reorganization meeting and Doug Witham seconded. The motion passed. It was moved that there would be a secret ballot for all contested races. The motion was seconded and passed.

Elections: Chairman:

Tanner Beymer moved to open nominations for Chairman. John Freeland seconded and the motion passed. Doug Witham nominated Thomas Lawford and John Freeland seconded. John Freeland nominated himself and it was seconded. Paul Agidius moved that the nominations cease, it passed with unanimous consent. Secret ballots were cast with the following results: Thomas Lawford - 11 votes, John Freeland - 5 votes.

Vice Chairman:

Thomas Lawford nominated Pete Warwick for Vice Chairman and Gordon Henley seconded. John Freeland was nominated and Paul Agidius seconded. Secret ballots were cast with the following results: John Freeland - 11 votes, Pete Warwick - 5 votes.

State Committeeman:

Barry Tenney nominated Paul Agidius for State Committeeman and John Freeland nominated Pete Warwick. Secret ballots were cast with the following results: Pete Warwick - 9 votes, Paul Agidius - 7 votes

State Committeewoman:

Nominations were made for Madeline McComas, Peggy Gottschalk, and Wendy Bouma. Secret ballots were cast with the following results: Peggy Gottschalk - 9 votes, Madeline McComas - 5 votes, Wendy Bouma - 2 votes

Youth Committeeman:

Thomas Lawford nominated Lathan Sonnenberg and Max Ryan seconded. There were no other nominations and Lathan was voted in by unanimous consent.

Secretary:

Gordon Henley nominated Wendy Bouma and it was seconded. There were no other nominations and Wendy was voted in by unanimous consent.

Treasurer:

John Freeland nominated Alex Navarro and Sally Browning seconded. There were no other nominations and Alex was voted in by unanimous consent. Alex has been authorized to be a signer for all bank accounts.

Precinct Committeeman Representative:

Sally Browning nominated Madeline McComas and Max Ryan seconded. There were no other nominations and Madeline was voted in by unanimous consent.
